

## **THE MICROSOFT Calling, Meeting & Devices webinar COMPETITION**

### **1. COMPETITION TERMS AND CONDITIONS**

These are the official rules for the promotion ('Competition Terms and Conditions') in the form of the Microsoft Calling, Meeting & Devices webinar competition, hereinafter to be referred to as the 'Competition'. The Competition is offered and sponsored by Microsoft B.V., having its registered office at Evert van de Beekstraat 354, 1118 CZ, at Schiphol, the Netherlands. In the rules the words 'Microsoft', 'we', 'our' and 'us' relate to Microsoft B.V. The words 'you' and 'yourself' relate to a participant who is eligible to participate in the Competition.

### **2. WHEN CAN YOU PARTICIPATE IN THE COMPETITION?**

This Competition will begin on 1<sup>st</sup> of september 2020 at 00:01 hours [Central European Time ('CET')] and ends on 6<sup>th</sup> of november at 23:59 hours [CET] ('**Entry Period**'). Only entries received within the Entry Period will be eligible.

### **3. CAN YOU PARTICIPATE?**

You can participate in the Competition if:

- you are a legal resident of the Netherlands, registered in the population register; *and*
- you are at least 18 years of age at the time of entry; *and*
- you are NOT an employee of Microsoft Corporation or of a subsidiary of Microsoft; *and*
- you are NOT involved in any aspect of the administration and the implementation of this Competition; *and*
- you are NOT direct family (parent, brother, sister, husband, wife, child) or family member of an employee of Microsoft Corporation, of an employee of a subsidiary of Microsoft Corporation or of a person who is involved in any aspect of the administration and the implementation of the Competition.

### **4. HOW DO YOU PARTICIPATE?**

You can participate in the Competition by watching at least 6 out of 12 webinars you will automatically participate in a lottery to win one of 15 Microsoft Teams certified devices.

Per participant we will accept 1 entry/entries. We are not responsible for entries which we do not receive for any reason whatsoever or for entries which are disqualified.

Entries received outside the Entry Period, as well as incomplete or unreadable entries will automatically be disqualified.

There are no costs attached to participation in the Competition. It is necessary, however, to send your entry to us. There may be costs attached to this. Microsoft does not charge any additional costs.

## **5. WHAT PRIZES CAN YOU WIN?**

If you are the winner of the Competition you will win the following prize:

One [Certified Microsoft Teams device](#) out of the pool of 20 devices which includes headsets, speakerphones and desk phones. Valued between €150,- and €550,- per device.

If for any reason whatsoever the promised prize is not available, we reserve the right to replace this prize by (a) prize/prizes of equal or higher value. Per winner only one (1) prize will be awarded.

The prize cannot be exchanged for cash or for any other good or service. As a chosen winner it is not possible to appoint somebody else as winner. If you are not able or not prepared to accept your prize, we will award this prize to another potential winner. If you are a potential winner and younger than 18, you have to show the written consent of one of your parents or guardian to participate in this Competition.

## **6. HOW WILL THE WINNER BE CHOSEN?**

In the month after the Entry Date we (or a third party designated by us) will from all eligible entries draw or have drawn in a random manner the potential winner(s).

## **7. HOW CAN YOU BECOME AWARE THAT YOU HAVE WON A PRIZE?**

Within seven (7) days after the winners have been determined we will inform these winners by sending a notification to the email address, the telephone number or the postal address (if applicable) which they have provided with their entry. If for any reason whatsoever a winner cannot be reached, we may award the prize to another winner.

Should a dispute arise about who is the potential winner, than in as far as we are concerned the potential winner will be the authorized holder of the email address used in the entry for the Competition.

**8. TO WHICH TERMS AND CONDITIONS ARE YOU AGREEING WHEN PARTICIPATING IN THIS COMPETITION?**

- The Competition Terms and Conditions as included in this document;
- You, as far as permitted by law, indemnify Microsoft, its parent companies, subsidiaries, affiliated companies, employees and representatives, respectively and indemnify Microsoft with regard to all liabilities or any injury, loss or damage of any nature whatsoever as a result of or in connection with the Competition or the prize won;
- The decisions of Microsoft are final and binding with regard to all matters in connection with the Competition.
